

WHATS BEEN HAPPENING



Bus Stops and Shelters **Cleaned, Repaired and Being Adopted**

One of the very first things the association did was respond to complaints about dirty bus shelters on Racecourse Road. This led to Greenham Parish Council being lobbied to adopt them going forward. This is now well under way.

We also managed to get GPC to adopt the bus shelters opposite the rail station. Our thanks to GPC for doing that.

Community Hub **Offer to gift building to Greenham Parish Council**

The RRA managed to get an agreement in principle from DWH and GPC for the potential of a community centre. With that done, all residents will now receive a survey from Greenham Parish Council asking: 1) Do you want one? 2) What do you want it to do? The initial RRA survey showed about 55% wanting one and 45% saying no thanks.



ACHIEVING OUR OBJECTIVES

One of the aims of the Residents' Association was to ensure we had a louder voice at Greenham Parish Council.

We now have four councillors on Greenham Parish Council who are also Residents' Association members and who live in the Racecourse Ward. There is a space for a fifth. Is that you? The committee would like your feedback on whether we should attempt to get people elected as West Berkshire councillors. A louder voice there is also one of our objectives.

A Word on Parking

Parking is a well-known issue for many residents, and people often ask what can be done. The Residents' Association is pushing as hard as it can to get the roads adopted across the estate. Only once that happens will any form of enforcement through West Berkshire Council become genuinely possible.

The "when" is controlled by the developer and West Berkshire Council. We will continue to communicate with them directly and via our district Councillors. However it may well be another 2-3 years before that is finished!

Dog Bins Remus has funds


On talking with Remus, it seems they have funds to install some extra dog waste bins.

Results from the RRA survey on a potential community centre

Although the survey showed a 10% weighting in favour of having one, there were also substantial concerns. It should be noted that, with only 101 responses, the sample size falls short of being



statistically significant given the number of people living here.

The RRA councillors therefore amended the motion to GPC regarding next steps, focusing purely on conducting a more substantial survey, which would then inform a decision on whether to proceed.

The RRA survey has at least provided a starting point for GPC and identified the

most significant issues that would need to be addressed. Among these, the four most prominent were:

Anti-Social behaviour, 2) Parking, 3) Costs to residents / long-term viability and 4) A belief that there is already enough.
